RE: Glover Park Village grant request

The OANC has received a copy of a grant request for 3B from the Glover Park Village for Digital Awareness and transportation. I have reviewed the application and found it to be an impermissible use of ANC funds because it does not benefit the community as a and may, depending on the recipient, duplicate services offered by the District of Columbia. This is further outlined below.

ANC grants must be for "public purposes within the Commission area." A public purpose is one "that benefits the community as a whole and is not done for the primary purpose of benefitting a private entity." Based upon the budget, the maximum number of recipients would be fifteen persons, ten receiving gift cards and 5 receiving iPads. To that purpose "[e]ach proposed ANC grant must be carefully scrutinized to ensure that it will benefit a significant part of the public, not just a few individuals." The OAG has previously determined that grants that "benefits only 15 children out of a commissioner area containing over 20,000 residents" could not be found to meet the Public Purpose requirement.⁴

The Department of For Hire Vehicles has a program where veterans may ride taxis for free. https://dfhv.dc.gov/page/vetsride The program is limited to DC Veterans with an annual income of \$45,000 or less a year who can receive four (4) vouchers a month for free rides for essential tasks such as medical appointments, job interviews, and educational opportunities. There is a potential impermissible overlap between the two programs and if the proposal was otherwise permissible, it would need to be adjusted to remove the overlap.

Conclusion
