Ms. Cardille:

Thank you for the submission of your grant application. I have copied Peter Wood the Chair of ANC 1C and Commissioner Michelson-Horowitz on the SMD Commissioner for your school on this email. Your application was for funding for a trip to Puerto Rico for your students.

Unfortunately, funding for travel outside the Washington metropolitan area is a prohibited expenditure for ANCs, specifically D.C. Code 1-309.13(l)2). (For the Commissioners on page 58 of your Pocket Guide).

Normally I would direct you to your Councilmember's office to ask for Constituent Services funds, but Councilmember Nadeau does not have such a fund. The 5 at large Councilmembers have such funds and that would be Chair Mendelson, and Councilmembers Henderson, Bonds, Robert White, and Councilmember McDuffie.
